Please note that usually you need to purchase **at least** the number of Details Plus licences you have on your master site. Details Plus can then be used on this and ALL sub-sites or undocked users with the same GoldMine number. Details Plus is also keyed to the same licence number.

For a GoldMine 4, 5 or 6 system, to see these, click Help>About in your **central/network** GoldMine. This will show a licence number such as E-NNNN-YYYYYYYY as shown on the right, where 0005 is the licence count and the **8 digit number** 60165731 is the main GoldMine licence number.



For a GoldMine 7 or Premium Edition system, still click Help>About but the number shown will be like E-0005VV-123456-XXXXX-XXXXX-XXXXX. Here the 0005 is the licence count and 123456 is the licence number which is **6 digits only**.

If you only want to use Details Plus on some sites it MAY be possible to purchase





fewer licences. Please contact us for information on other configurations.

If you are installing a **new GoldMine system**, you will have one or more GoldMine licence certificates to install. In such cases the 6/8 digit number is the number shown on the **first** licence you install and the total number of licences is the sum of the licence counts shown on the certificates.
